Content Restriction
• Adult Toys
• Alcohol-containing items, flavoring extracts, cooking wines, wine making kits, books on manufacturing of such drinks or any foods with alcohol, etc.
• Alerting apparatus (such as bells, sirens, burglar or fire alarms...) releasing sounds of police car sirens or of some animals
• All kinds of religious books
• All shipments containing jewelry including, but not limited to, gold, silver, platinum, pearls, stones and diamonds, etc. are prohibited through courier
• All types of statues
• All weapons and firearms (real or ornamental), including guns, ammunition, fireworks, spears and other edged weapons, etc. (owner subject to investigation, fines, and/or imprisonment)
• Amiante
• Antiques (breakable and/or fragile)
• Any brand copy product
• Any item contrary to the Royal Family, Saudi Arabian or Muslim beliefs or morality
• Any item that has a hidden camera or anything that can be used as a spying device (pens, watches, etc.)
• Any items which depict or display the female anatomy (other than for strict medical purposes)
• Any product mentioning Fake Origin country name
• Arms or it spare
• Articles contrary to Muslim or Saudi Arabian beliefs or morality will not be allowed into the country
• Asbestos and products thereof
• Binoculars or telescopic equipment
• Blank bills or invoices with headings in the name of foreign companies operating abroad.
• Blank Passport
• Chemicals, Haz and Non-Haz
• Chewing tobacco, naswar, snuff (sawika),
• Commercial shipments containing jewelry including, but not limited to, gold, silver, platinum, pearls, stones and diamonds, etc.
• Compact discs
• Computer software
• Contaminated goods or nuclear dust
• Cosmetics
• Coupons of Hadi (sacrificial animal), sacrifices, ransoms (Fidyah) and charity. (paper document referring to sacrificial animals - sacrifice offered during Hajj; Sheep, camel, cow...)
• Dangerous Goods as defined by IATA (Intl. Air Transport Association)
• Disguise face masks, full masks or partial masks
• Drink having description of Zamzam (Zamzam is a holy well located in Saudi Arabia)
• Drugs & narcotics of all types, names, & forms
• Drugs, Prescription and Non-Prescription ( more info on SFDA.GOV.SA)
• Electrical Shocker
• Electronic quran
• Electronic Sheesha
• Fake Identities
• Films: 8mm, 16mm & 35mm
• Films: 8mm, 16mm & 35mm
• Films: entertainment
• Films: promotional, training
• Fireworks used by children
• Flying objects that can be moved by remote control, and their spare parts like drone

• Mummified animals
• Narcotics
• Night vision binoculars through which it is possible to see in the dark, binoculars that capture images at night and binoculars for targets identification
• Nutmeg fruits
• Objects of human or animal form (statues, figurines, carvings, etc.)
• Plants and Plant Products
• Pokemon toys
• Politically sensitive material
• Pork and its meat, fat, hair, blood, guts, members and anything extracted from it.
• Pornographic material and literature including fashion magazines with people wearing undergarments or swimsuits
• Pornography in any form
• Postal envelopes
• Prototypes of Qaaba shrines, crosses, Christmas trees, Electronic Mosque Niches (Mihrab), and any goods not in-line with the Islamic doctrine
• Radio transmitter/communication equipment (including walkie-talkies, short-wave, VHF, marine, police band equipment, etc.)
• Raw natural organic fertilizers of animals or vegetal origins
• receiver satellite
• Seeds
• Self-balancing electric boards also known as "Hoverboards" (CoCs for such products are not allowed until further notice):
• Sex toys and other items related to sex
• Soil samples
• Sound guns, rifles and the like looking like a real gun
• Specters or watches or any accessories with camera

• Stuffed animals - Such items will be removed from all incoming shipments at the time of Customs clearance and sent to the Ministry of Information for review
• Synthetic Marijuana (K2)

• Toys operated by fuel
• Traffic police radar detectors

• Used or refurbished tyres
• Vehicles for children with 2-4 wheels, that do not exceed 50 cm in height from the wheels axle, in addition to vehicles that are driven on batteries if their speed exceeds 10 km/hr.
